Project Narrative:

American Trauma Society, PA Division: ABLS Classes Offer and provide a series of Advanced Burn Life Support (ABLS) Provider Courses to Medical Doctors, Nurses, Paramedics and Emergency Medical Technicians. The ABLS Course is an eight-hour course designed to educate and prepare pre-hospital and hospital personnel in the event of accidents or disasters involving burn injury. The course provides guidelines in the assessment and management of the burn patient during the first 24 hours post-injury. Following a series of lectures, case studies are presented for group discussion. Students also work with a simulated burn victim to reinforce assessment, stabilization and transfer criteria.

Establish dates, secure sites and conduct a minimum of ten ABLS courses with the ability to host a minimum of 20 participants in each class. In the event more students apply, additional or larger classes or both shall be attempted.

Coordinate the classes through the American Burn Association (ABA), the developer of the ABLS course, which shall include:

Paying tuition costs which include course materials and ABA certification for each student that completes the course,

Paying expenses of ABA Preceptors for program oversight.

Obtain and pay for the following for each course: ABA Certified Instructors and mileage reimbursement, Ancillary Expenses to include: AV Technician, Victims, and Makeup Artists.

## **Ebola Training & Exercise/Ebola Transport Teams**

Amount:

\$550,000.00

Project Narrative:

Cooperate with the Pennsylvania Department of Health (Department) to support the coordination to plan, train, and exercise, Emergency Medical Service (EMS) providers and pre-hospital partners and 911 Call Center/Public Service Answering Point. Plans and exercises regarding the disposal of medical waste generated through caring for Ebola or other highly infectious patients shall be included.

Support the coordination for a minimum of one training and one exercise, focusing on the Pennsylvania Concept of Operations (CONOPS) for Ebola, and specifically focusing on EMS and pre-hospital partners, to include 911 Call Center/Public Service Answering Point, which shall be in addition to EMS participation in the general Health Care Coalitions training and exercising. Additionally, the Grantee shall support all regional councils to finalize any plans and annually train and exercise these plans regarding disposal of Ebola generated medical waste. The Grantee shall support each regional council to complete a total of two trainings and two exercises annually.

Support the coordination for planning, training and exercising and equipping of the Departments' identified EMS transport services related to Ebola patients or persons under investigation. Additionally, the Grantee shall procure Ebola related transport services as well as personal protective equipment specifically designated for the EMS Ebola Transport Team for actual transport and training.

Support the coordination to educate, train and equip EMS personnel, as approved by the Department, to prepare for, respond to, and recover from significant events. The Grantee shall support two trainings for each EMS Regional Council. Training courses and topics may include preparedness activities to improve capabilities to respond to and recover from highly infectious and emerging diseases such as Ebola.

Narrative:

Held 14 in-person training sessions for the new licensure application process in EMS Registry

Developed and forwarded a packet of information regarding the new reregistration process and mailed to every provider upon renewal

Held a one-day summit for community paramedicine to bring together community paramedicine program leadership, insurance company representatives, and other health partners in an effort to remove obstacles to making it a successful model

Held a two-day conference to inspire EMS innovation

Developed IALS workgroup to identify opportunities for utilization of IALS with a focus on inserting the new level of care into our existing dispatch system

Coordinated Emergency Medical Dispatch training sessions for eight county PSAPs Provided Tactical Emergency Casualty Care classes to our region – 316 students received certification

Held and assisted in the training of the Active Attack Integrated Response courses Established a mental health workgroup to address specific issues of mental and behavior health, which submitted suggestions for protocol changes in November

Partnered with mental health professionals to develop an EMS and Mental Health Emergencies continuing education course for Train PA

Developed and conducted education on BLS aspirin administration
