

The EHSF would like to remind EMS agencies the Department of Health is the lead regarding information about the Coronavirus. The EHSF will continue to disseminate information provided by the Bureau of EMS for EMS agencies as quickly as possible. Information and guidance are changing rapidly.

### **Regional Status**

As of the time this document was written (Friday, 03/27/2020 at 2130 hours), there are 2,218 confirmed cases of COVID-19 throughout Pennsylvania and 22 reported deaths. Please know the number of cases can change frequently.

#### 2020-08 Issued Extension to EMS Certification Expiration Dates

The Bureau of EMS adjusted the expiration dates of EMS providers expiring on 03/31/2020 or 04/01/2020 who did not already renew their certification. The system will now display their expiration date as 07/01/2020. If these providers meet the renewal requirements, then they will be able to reregister their certification after 04/02/2020. This includes EMSVO, EMR, EMT, AEMT, Paramedic, PHRN, PHPE, PHP, and MCP.

### No Transport Tool for Influenza-like Illness

Information regarding no transport of persons with influenza-like illness was e-mailed this evening. The EHSF offered a tool for EMS providers use to assist with the EMSIB 2020-06. The tool will help the EMS provider effectively communicate with a medical command physician to determine if the patient may remain at home. Additionally, home self-care instructions were provided to help EMS provider know what information to share with the patient and offer a copy as their EMS agency desires.

#### Can an EMS Provider work?

The EHSF developed some documents to assist EMS agencies with monitoring employees for symptoms and understand when an EMS provider may continue working or should remain home. The guidance was sent by e-mail this evening.

### **Patient Care Reports**

ESO ePCR users can use the COVID-19 data elements. EMS agencies should consider educating their personnel to use these features. The data reporting for suspected COVID-19 patients will be beneficial in the future. Specifically, ESO permits the EMS provider to document PPE usage, and there is a report in analytics to monitor PPE used. This will be valuable as Local, State, and Federal entities ask for burn-rate/usage of PPE when determining distribution plans for replenishment.

### Theft of PPE

### **Infrared Thermometers**

The EHSF made a regional purchase for non-contact, infrared thermometers for licensed, transport-cable units in our region. Specific information was sent by e-mail on Thursday. The shipment is anticipated to arrive in 1-2 weeks. Matt will provide a distribution plan.
