

The EHSF would like to remind EMS agencies the Department of Health is the lead regarding information about the Coronavirus. The EHSF will continue to disseminate information provided by the Bureau of EMS for EMS agencies as quickly as possible. Information and guidance are changing rapidly.

Regional Status

There are 34,528 confirmed cases of COVID-19 throughout Pennsylvania and 1,564 reported deaths.

Eligibility to Return to Work

On 19 April 2020, the PA Department of Health updated their guidance for employee eligibility to return to work for essential workers in Pennsylvania. Attached to the e-mail with this update, EMS agencies will find an updated flowchart.

Basically, even if an EMS provider was exposed to a patient, family member, coworker, or other person who tested positive for COVID-19 or is a person under investigation, they are no longer required to selfquarantine for 14 days as long as symptoms do not appear. Therefore, they can work.

The provider will need to monitor their temperature and symptoms daily. The provider will also need to wear a facemask while in the workplace. If symptoms appear, then the provider cannot work.

Dispatching Update

The EHSF updated the screening tool used by the 9-1-1 centers to no longer question if an individual is in self-quarantine. The 9-1-1 centers will now ask, "are you or anyone on location suspected of or have COVID-19 symptoms?" The dispatcher will also ask questions related to contact with someone with flulike illness, status as a healthcare worker, and the presence of specific COVID-19 symptoms. If yes is answered to any of the questions, then the dispatcher will tell the EMS crew "universal precautions advise

How to Reduce Exposure to COVID-19 while Working?

The EHSF developed a one-page guidance document to identify steps an EMS provider can take to reduce the risk of exposure to COVID-19 while working. Attached to the e-mail with this update, EMS agencies will find the guidance document.

Pearson Vue Testing Availability

The EHSF learned Pearson Vue now has a tool to search for available seats for cognitive EMS exams. EMS candidates who have been attempting to find a test location, can search for a seat prior to paying the exam fee. The candidate will go to: <u>https://home.pearsonvue.com/nremt</u>. They will click on "seat availability" on the right side of the website. Next, they will find an exam by typing the EMS certification level (i.e. EMR, EMT, advanced EMT, or paramedic). After searching and reviewing the testing policies, they will click next. The candidate will enter their address to locate testing centers nearby. A listing of testing centers will display. The candidate can select a testing site, click next, and then search if a seat is open via a calendar. After the candidate finds an available seat, then they can go into their NREMT account, submit payment, obtain their authorization to test, and then schedule the exam. This search tool reduces the risk of candidates paying the nonrefundable exam fee and being unable to locate a test within 90 days.
