



The EHSF would like to remind EMS agencies the Department of Health is the lead regarding information about the Coronavirus. The EHSF will continue to disseminate information provided by the Bureau of EMS for EMS agencies as quickly as possible. Information and guidance are changing rapidly.

Based on data from the Department of Health, there are 51,845 confirmed cases of COVID-19 throughout Pennsylvania and 3,106 reported deaths.

N95 Mask Decontamination

The Governor's Office provided a press release today regarding process to have N95 masks decontaminated for EMS and healthcare workers. Battelle Memorial Institute was awarded a federal contract to deploy decontamination units across the country. There is a site operational in southeast Pennsylvania with the ability to decontaminate up to 80,000 N95 respirators per day. The company will use a high concentration, vapor phase hydrogen peroxide. This method can permit a N95 mask to be decontaminated up to 20 times without degrading its performance.

EMS agencies interested in using this resource should follow the content listed below as provided in the press release:

Participating entities will collect worn respirators each day in accordance with an approved procedure, and the PPE will be labeled with a barcoded serial number that will be used for tracking the PPE chain-of-custody throughout the decontamination process. This procedure ensures that the healthcare system receives its own respirators back. ([Link to Preparation and Collection of N95](#))

How to Sign-Up

Step 1: Download the [Services Agreement \[doc\]](#), have your authorized representative sign it and return by email to PPEDecontaminationContracts@battelle.org. We will issue back a countersigned agreement.



Step 2: Once your signed services agreement has been sent, download and complete the [Site Locations and POC Information form \[xlsx\]](#) and return by email to Erica Howat at howate@battelle.org.

Note: Each row of data in the excel sheet should be for a physical location at which you would like to send and receive masks. Example a countywide fire department would want to put in a line for each firehouse so each can send and receive masks directly.

Step 3: 3-digit site codes for each location will be provided to you after the services agreement is executed. The 3-digit codes are to be marked on each N95 respirator you collect. Begin collecting and labeling your N95 respirators. Each N95 respirator must be handled and labeled properly to be decontaminated. Below are specific instructions for details on how to collect, label, and package your respirators for shipment.

It is VERY IMPORTANT that every N95 is properly labeled and free of any visible soiling such as blood, bodily fluids, and makeup. We cannot decontaminate N95s that do not meet these requirements.

Step 4: When you prepare to send your N95s, you will need to download and fill out the [Chain of Custody Form \[xlsx\]](#). Please provide one form per shipment.

Battelle will coordinate directly with entities interested in using this important service through a service agreement and registration process. The terms of its federal contract allows for hospitals and other care providers to **access these services at no cost**.

Thermometer Education

The thermometers have been distributed to EMS agencies with transport capable EMS vehicles. As EMS agencies began to use the non-contact infrared thermometers, some best practices have been identified. EMS providers are encouraged to read the user manual prior to use. [contact-thermometer-ir-100/](#). Additionally, an instruction sheet created by an EMS agency within our region is attached to this e-mail.

While using a thermometer seems simple, there are steps to take to reduce inaccurate readings.

- Hold the device 1-2 inches from the patient's forehead
- Pull hair away that may be covering the forehead
- Wait 15 minutes between ambient temperature changes to use
- Avoid drafts
- Wait 1 minute between scanning when rescanning the same person

Reporting COVID-19 EMS Agency Status

The EHSF is continuing to encourage EMS agencies to report how the COVID-19 pandemic is impacting their agency. The EHSF developed a short reporting tool, which is available on the EHSF website.
